Within 3 working days after receiving this contract, the host shall sign and stamp on it and fax or mail it back to the exhibitor. Meanwhile, the exhibitor shall remit 50% of the booth fee into the account specified by the host within 7 days after the contract is entered into, and pay off the balance before September 10, 2011. In case of delayed payment, the host has the right to cancel or adjust the abovementioned booth;</li> <li>4. The booth shall be deemed as confirmed after the exhibitor signs the contract and make the payment. If adjustment of the booth is indeed needed, the host shall issue a "Booth Change Notice" to the exhibitor for advice and only can start adjusting the booth with the approval of the exhibitor;</li> <li>5. If the exhibitor needs to cancel the contract before the expiration date for any reason, it shall inform the Host in writing and make the proper payment before the date of cancelation according to the payment date provided in the exhibition contract;</li> <li>6. This contract shall remain valid since its signing date until October 12, 2011. The two parties shall fulfill their respective rights and obligations. Except for force majeure, no party shall commit breach of the contract;</li> <li>7. The contract is in duplicate, each party holding one.
